

Getting started

You may be asked to send us evidence to support your application. Here's our advice on the best way to do this...

Preparation is key!

Before you begin your application

- Do you know your exact income and expenditure?
- Do you have all the right information?
- Complete a budget sheet with a FCA (Financial Conduct Authority) approved adviser
- Collate all your personal information and anything that relates to your circumstances

Use our evidence checklist to the right when you come to compile everything you need for your application.

Need a bit of help?

There's always someone on hand to assist you.



Can't get online?

Ask a friend, neighbour, or visit your local library



Can't do it yourself?

Ask a family member, Citizens Advice or Support Worker



Can't find evidence of your benefit payment?

Ask Department of Work and Pension, Pension Service or visit www.gov.uk



Can't find income evidence?

Ask your employer or payment provider



Can't find medical evidence?

Ask your GP for a patient summary which is free (avoid asking for a medical letter as you may be charged)



Can't complete a budget sheet yourself?

Ask your nearest FCA approved adviser, you can find one on www.register.fca.org.uk

What to do if things change...

Don't worry, we understand that these things happen, just let us know as soon as possible. You can upload or email us photocopies.



Power of attorney

We'll accept the evidence with the Power of Attorney's information on it, but you'll need to upload proof of your address and a copy of Power of Attorney document

Moving or moved house

Upload a copy of the Tenancy Agreement or Council Tax letter.

Changed name or different name

Upload a copy of the Change of Deed poll, Divorce Papers or Marriage Certificate.

Someone has moved in or out

Tell us who and when.

Job changes or income changes

Tell us what's happened and upload a copy of your previous and current wage slips.
